Washington, D.C. -The Washington region's premier contemporary dance company, Dana Tai Soon Burgess & Co., debuts its latest work at Dance Place (www.danceplace.org), October 22-24. Performances are at 8 p.m. on October 22 and 23, and at 7 p.m. on October 24. Tickets are \$17-22.

Charlie Chan and the Mystery of Love evokes 1930s Hollywood to explore stereotypes, Tinseltown fantasies, and the universal quest for love and self-knowledge. The multi-media, autobiographical piece is inspired by the popular film detective Charlie Chan and uses both video projection by Sara Brown of MIT, spoken word text by performing artist Wilma Consul, and a nostalgic soundtrack of 1930s and '40s music.

"In working on the new dance, I was inspired by my early teen years in New Mexico," says choreographer/artistic director Dana Tai Soon Burgess, "a time when my fantasy TV world intersected with my reality and allowed me to find a sense of self-worth in the midst of a lot of cultural confusion."

Charlie Chan and the Mystery of Love premieres on an evening-length program that also includes Burgess's acclaimed "Island" (2009).
